# Application Guide for Doctoral Degree Program Under "The China State-Funded Postgraduate Overseas Study Program" Commencing in September 2024

#### 1. Outline:

Tokyo Institute of Technology ("Tokyo Tech") is accepting applications to the Doctoral Program commencing in September 2024 under the "China State-Funded Postgraduate Overseas Study Program." For applicants who are interested, please apply for International Graduate Program (B) or IGP(B) at Tokyo Tech. Selected candidates with excellent academic records will be exempt from application, enrollment and tuition fees.

- 2. Enrollment Date: Late September 2024
- 3. Type of Program: Doctoral Program
- 4. Number of Admitted Students: Several students for each Department

## 5. Eligibility:

Applicants must be Chinese nationals who satisfy the following conditions:

- (1) Must apply as student in the Doctoral Program under the "China State-Funded Postgraduate Overseas Study Program" specified by China Scholarship Council (CSC).
- (2) Must have completed or be expected to complete master's degree by the day before the enrollment date.

## 7. Application Deadline:

Please refer to the Application Guide for <u>International Graduate Program (B)</u>. (Note that application documents must be received by the Admissions Division, Student Services Department on or before October 15, 2023.)

## 8. Admission Screening:

Please refer to the Application Guide for <u>International Graduate Program (B)</u>. (Selection will be based on screening of application documents, online interviews and/or written examinations as designated by departments.)

9. Notification of Admission Results:

Notification of admission results will be mailed to each applicant in January 2024.

At the same time, selected candidates with excellent academic records will receive Letter of

Confirmation from Tokyo Tech indicating that they may be exempt from paying tuition and

other fees. This Letter is required when the applicant subsequently applies to "China State-

Funded Postgraduate Overseas Study Program" specified by CSC.

10. Application, Enrollment, and Tuition Fees:

As stated in item 9 above, selected candidates with excellent academic records may be

exempt from paying application, enrollment and tuition fees to Tokyo Tech, but application

fee must be first paid by all applicants. Tokyo Tech will later refund the fee to those who will

be exempt. For payment procedures, please refer to the Application Guide. All other accepted

students who wish to enroll in the Doctoral Program must pay these fees as required during

the admission procedures.

Application fee: JPY 30,000

Enrollment fee: JPY282,000

Tuition: JPY 635,400/year

Note: Even if the applicant is recognized to have excellent academic records and issued

Letter of Confirmation from Tokyo Tech, he/she must be selected as scholarship recipient by

CSC to be actually exempt from tuition and other fees. If the selected candidate is not

selected as scholarship recipient by CSC, he/she must pay application, enrollment and

tuition fees to Tokyo Tech despite being issued Letter of Confirmation from us.
